The Points towards a Championship shall be awarded to the Winners Dog and Bitch of each breed or variety based on the actual number of dogs or bitches competing in that breed or variety.

If the dog designated Winners Dog or Winners Bitch is also awarded Best of Breed or Variety, the dogs of both sexes that have been entered for Best of Breed or Variety competition and that have been defeated in such competition, shall be counted in addition to the dogs that competed in the regular classes for its sex in calculating championship points.

If the dog designated Winners Dog or Winners Bitch is also awarded Best of Opposite Sex to Best of Breed or Variety, the dogs of its own sex that have been entered for Best of Breed or Variety competition that have been defeated in competition for Best of Opposite Sex, shall be counted in addition to the dogs that competed in the regular classes for its sex in calculating championship points.

After points have been computed for Winners Dog and Winners Bitch subject to the above two stipulations, the dog awarded the Best of Winners shall be credited with the number of points calculated for Winners Dog or Winners Bitch, whichever is greater.

In counting the number of eligible dogs in competition, a dog that is disqualified, or that is dismissed, excused or ordered from the ring by the judge, or from which all awards are withheld, shall not be included. Any dog which shall have won fifteen points shall become a Champion of Record, if six or more of said points shall have been won at two shows with a rating of three or more championship points each and under two different judges, and some one or more of the balance of said points shall have been won under some other judge or judges than the two judges referred to above.

The winners of the veteran sweepstakes classes will compete for Best in Veteran Sweepstakes and Best of Opposite Sex to Best in Veteran Sweepstakes.

SWEEPSTAKES AWARDS

After a 30% deduction for expenses, the remaining Sweepstakes entry fees shall be awarded to the class winners on a proportional basis:

50% to be divided equally among the first place winners;

50% to be divided in the following manner:

60% to the Best in Sweepstakes Winner

40% to the Best Opposite Sex to Best in Sweepstakes Winner.

The same applies to Veteran Sweepstakes cash awards.

NOTICE TO EXHIBITORS

Conditional, unsigned, incomplete, telegraphed, telephoned or **FAX** entries cannot be accepted. Entries must be on official AKC forms with the AKC agreement on reverse side.

Owners are responsible for errors on entry blanks.

Entry fees will not be refunded in event of error or cancellation of entries after the published closing date, nor in the event that a dog is absent, disqualified, excused by the Veterinarian or Judge, or barred from competition by action of the Show Committee or because the dog is ineligible to compete due to an incorrect entry.

Returned checks do not constitute a valid entry fee. The Show Treasurer will add a collection fee to the amount of each returned check. Subsequent returned checks from the same exhibitor may result in their being put on a cash only basis.

Refund for cancellations prior to closing will be made after the show.

A recording fee of \$.50 will be required for each dog entered at any licensed or member club show, obedience trial or tracking test. This recording fee is to be collected by the show-giving club and paid to AKC. If a dog is entered in more than one class in the show, the recording fee is to be collected on the first entry only. (Chapter 11, Section 2 of the AKC Dog Show Rules)

There is no provision offered for unentered dogs at this show.

Dogs must be ready for judging. No provisions are available for notifying exhibitors or their agents of class judging. Judges need not wait for any dog. Owners or agents alone are responsible for the presence of their dogs in the judging ring.

Dogs need to be at the show only at scheduled judging time and may leave immediately thereafter unless required for further judging.

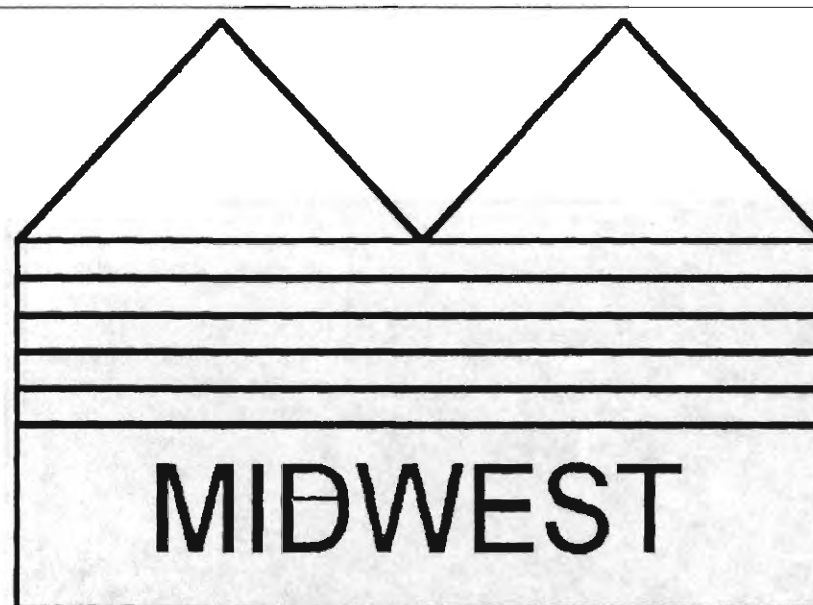
All dogs must be held on leash or kept in pens/crates except when being judged.

No tents, large umbrellas, or equipment of any sort will be allowed within 25' of any ring. Grooming and exercising must be done in designated areas.

The IRISH SETTER CLUB of ARIZONA, INC will not be liable for any loss, theft, injury and/or death of dogs entered in the show, whether said loss, theft, injury and/or death is caused by carelessness or negligence of any other person or by any other cause.

AGENTS NAMES ARE INCLUDED IN THIS CATALOG.

An agent is a person 18 years or older, other than an owner or co-owner, designated by the owner or co-owner of an exhibit to be handler of, and responsible for, the dog at the show. Agents' names may be followed by the initials which represent their AKC-recognized professional group affiliation or certification. Persons seeking the service of such an agent should familiarize themselves with the requirements for professional group membership or certifications which are available at the superintendent's office.

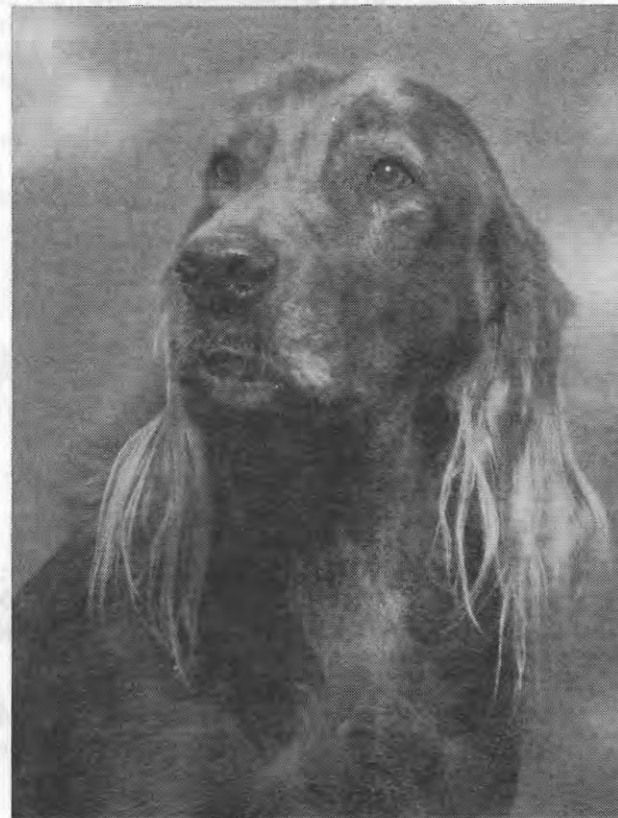

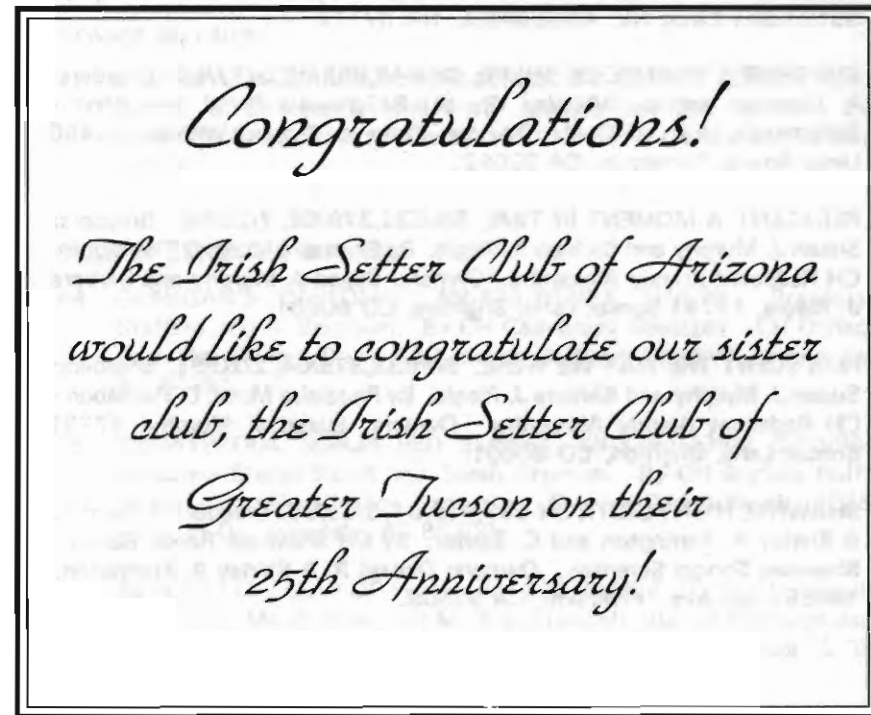
