## NOTICE TO EXHIBITORS

### ENTRY FORM INFORMATION

1. Closing dates for the entries is **6PM PST, Wednesday, November 1, 2017** at the SHOW SECRETARY'S address, after which time entries cannot be accepted, canceled or substituted.
2. Conditional, unsigned, incomplete, telegraphed or telephoned entries cannot be accepted.
3. Owners are responsible for errors on entry forms.
4. Entry fees will not be refunded in the event of error cancellation of the entries after the published closing date nor in the event that a dog is absent, disqualified, excused by the Veterinarian or Judge or barred from competition by action of the Show Committee or because the dog is ineligible to compete due to incorrect entry.
5. Changes or additional information cannot be made by telephone. Such information must be received in writing or telegraphed prior to closing of entries as published in the premium list.
6. No entry fee will be refunded if the show cannot open or be completed by reason of riots, civil disturbance, fire, an Act of God, public emergency, act of a public enemy, strikes or any other cause beyond the control of the club or Show Chairman.
7. Returned checks do not constitute a valid entry fee. The Club Treasurer will add a collection fee of \$20.00 to the amount of each returned check. Subsequent returned checks from the same exhibitor may result in their being put on a cash only basis.

If a dog is entered in more than one class in the show, the recording fee is to be collected on the first entry only. (American Kennel Club Rule, Chapter 14, Section 20).

### JUDGING

1. This show will be open from 7:00 a.m. to 7:00 p.m.

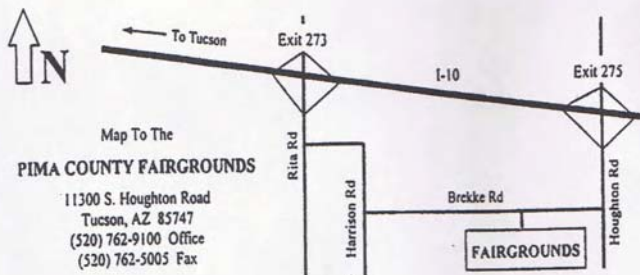

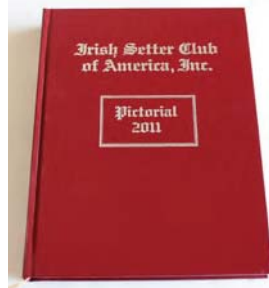
